

**Draft Minutes of Llangors Community Council Bi Monthly Meeting**  
**Held Remotely on Tuesday 8<sup>th</sup> September 2020, 7.00pm**

**2. Declarations of Interest for agenda items as per Members' Code of Conduct**

Cllr Jevons declared an interest in agenda item 12.

**3. Questions on agenda items from members of the public - None**

**4. Minutes of extra meeting on 12/8/20 and planning meeting 3/9/20**

The minutes were read and signed as a true and accurate record. Extra meeting; proposed by Cllr Jones and seconded by Cllr Griffin and planning meeting proposed by Cllr Scruby and seconded by Cllr Evans.

**5. Matters Arising from above minutes not listed on the agenda**

Llangors Churchyard bank repairs – Cllr Preece was hopeful that this work would be carried out by the end of September.

Webpage photos – Cllr Preece was thanked for taking photos which were now being uploaded onto the webpage.

**6. Coronavirus Covid-19 Pandemic update;**

**a) Glebe Community Field.** The play equipment was now in use and signs were in place reflecting Welsh Government guidance.

**b) St. Paulinus Churchyard.** It was understood that the rules on funerals had changed so the existing notices would need updating. (Action Clerk)

**c) Llangors Together.** Although requests for assistance had subsided, the team remain in place should any member of the public need support.

**7. Highway matters – update on all issues**

The ongoing list of highway issues had been distributed. Concerns continued to be raised by residents regarding the prospect of potential flooding of residential properties again this autumn/winter due to identified works having not been carried out by PCC. Cllr Bailey who had met with PCC officers earlier in the year agreed to follow the matter up. (Action Cllr Bailey)

River Cwy from the bridge to Brookside Nursing home - there was a lot of rubbish growing on the banks of the river again. The CC had cleared this two years ago to help with flood prevention. It was agreed to get this cleared again. Clerk to arrange. (Action Clerk)

C96 near Llangors School build out – the design of this had been agreed and it was anticipated works would commence soon.

Speeding and extra volume of vehicles in Llangors - extra traffic travelling through the village due to the closure of the A479 at Pengeffordd and an increased number of visitors to the area was causing concerns for residents. The Police had been in attendance observing and issuing fines for speeding vehicles. Cllr Durrant was in contact with PCC regarding more permanent solutions.

A sign outside a house near the Triangle, Llangors had been reported as dirty and obstructed by plants. Cllr Preece agreed to assess this. (Action Cllr Preece)

A BT cable hanging very low between the Vicarage and junction to Gilfach had been reported to the CC. The clerk had reported the matter to BT.

#### **8. Keep Wales Tidy “Local Places for Nature” project at Llangors Triangle – Cllr Preece**

Cllr Preece reported that there were wildflower seeds to be planted. Cllr Scruby agreed to assist with this. Cllr Griffin was thanked for watering plants and looking after the birdfeeder.

#### **9. Replacement of seat near PenyBrenin**

The safety of the seat was a concern and the replacement was due to be ordered and put in situ in May which was cancelled due to the pandemic. It was agreed to go ahead and order the new seat and replace it. In doing so the plaque will be installed on the seat remembering V.E. Day but the planned service to remember that day and dedicate the seat will no longer happen. (Action Clerk)

#### **10. Bi monthly finance report.**

This had been circulated, as attached to these minutes, and was agreed. The clerk reported that due to the pandemic there was a delay with Grant Thornton completing the external audit and a notice had been placed on the webpage indicating this as instructed by the Auditor General for Wales. It was reported that the Pension Regulator re-declaration had been completed. A pay increase for the Clerk in line with the NALC pay scale 20 was considered and unanimously agreed at £13.51 per hour back dated to 1/4/20.

It was noted that the Clerk had done some photocopying at Llangors Activity Centre and had not received an invoice for this. Cllr Preece reported that this was to be free of charge. Letter of thanks to be sent (Action Clerk).

**12. Glebe Community Field lease renewal**

A meeting had been held with ward councillors, the clerk and the Property Officer from the Church in Wales (CIW) to discuss the future of the site. The CIW appeared happy to agree a new lease, from 1/4/21. A twenty five year lease was requested along with some changes based on the current lease which the CIW appeared supportive of and will consider in due course.

**13. Roll out of Fibre Broadband update – Cllr Bailey**

Kirsty Williams had updated the CC with the current position. Powys County Council are to appoint an officer to assist with community broadband issues in the autumn. Cllr Bailey reported that a Community Interest Company (CIC) was being set up by some residents in order to engage with BT Openreach under the Welsh Government gigabyte scheme in order to achieve fibre broadband throughout the CC area. Whilst the CIC was separate to the CC, Cllr Bailey and Cllr Preece were willing to be part of the CIC. It was suggested that PCC be asked if there was grant funding available to assist with the CIC set up costs and that residents could be kept up to date with the ongoing plans via the Grapevine newsletter. Cllr Bailey to keep the CC updated with progress on the matter.

**14. Update from representatives: -**

**a. Llangors CIW Primary School Governing Body – Cllr Griffin**

Headteacher Lynne Jones had retired from that position although remains working at the school one day a week, assisting the now Acting Headteacher, Mark Williams. There were also some other staff changes in in the school. The Governing Body AGM is on 14/9/20.

**b. Discover Llangors & Bwlch Group – Cllr Owen**

In the absence of Cllr Owen, no update was available.

**c. Llangors Community Shop Committee – Cllr Owen**

In the absence of Cllr Owen, Cllr Preece updated those present. The lease of the land between the Community Centre and the Community shop had been agreed subject to the completion of a lease between the Community Centre and Powys County Council for a new playpark. The Shop Committee currently had a Just Giving page set up, crowdfunding for £5000 in order to cover some basic set up costs to continue to the next stage.

Alan Williams left the meeting at 8.28pm.

**15. Community Use of Llangors Playing Field update - Clerk**

**To consider and pass a resolution to exclude the public and press, under the Public Bodies Admissions to Meetings Act 1960, and the Council's Standing Order 3d, and discuss the matter confidentially due to its sensitive nature.**

It was unanimously resolved that the matter be discussed confidentially as set out. The CC await an agreed meeting with Llangors School Governing Body brokered by Clive Pinney, Head of Legal Services at Powys County Council.
