Draft Minutes of Llangors Community Council Bi Monthly Meeting Held Remotely on Tuesday 11th January 2022, 7.00pm

4. Minutes of bi monthly meeting on 9/11/21 and PAD meeting 16/11/21

The bi monthly minutes were read and signed as a true and accurate record. Proposed by Cllr East and seconded by Cllr Jones.

PAD minutes were read and signed as a true and accurate record. Proposed by Cllr Scruby and seconded by Cllr Owen.

5. Matters arising from above minutes not listed on the agenda

<u>Page 4 Powys Play Sufficiency Assessment.</u> As agreed, the drafted response was approved by Councillors and sent to PAVO as required. Thanks were given to Cllr Jevons and the Clerk for their work on the matter.

Page 5 Invasive species event. It was likely NRW would host an event. Clerk to follow up.

6. Coronavirus Covid-19 pandemic update

The Omicron variant has resulted in the infection rate being higher now than anytime previously in the pandemic. Booster jabs have been offered to all adults. Some restrictions had been reintroduced and as a result the Clerk had reviewed the position regarding St Paulinus Churchyard and the Glebe Community Field. Cllr Scruby confirmed that revised signs had been erected at the Glebe Community Field.

7. Glebe Community Field update

The Sakura Cherry Tree event held in December had been very successful. A plaque had been supplied with the trees so the only cost incurred was for the love spoon gifts and the daffodil bulbs, amounting to just under £50. A press release had been drafted by ClIr Scruby, agreed by Councillors and was printed on the front page of the Brecon and Radnor Express on 29/12/21. Thanks had been sent to the photographer, two residents involved and the editor of the newspaper. Thanks were extended to ClIr Scruby and ClIr Jones for preparations in the run up to the event and to those Councillors who attended.

General maintenance work at the site is to be carried out by Councillors and arranged by Cllr Scruby. The invoice for the grass cutting contract had been received. The final cut of the season was not carried out due to the ground being so wet. It had been proposed by the contractor that an early cut would be done next season to compensate for that. This was unanimously agreed. Clerk to liaise with contractor and pay the invoice.

8. St Paulinus Churchyard - approve increase in fees

The fees had been reviewed in line with the Church in Wales fees and were approved.

Cllr Jevons joined the meeting

9. The Local Government and Elections (Wales) Act 2021: Draft Statutory Guidance for Community and Town Councils. Consultation for discussion and response.

The implications for the CC were discussed which included enabling multi location meetings, public participation at meetings, annual reports, councillor training, timescales with minutes and the need to update the Standing Orders. It was agreed that hybrid meetings and much of the legislation was positive, albeit potentially an increase in commitment of members time to the role may be necessary and initially there will be some costs to the CC, unless grant funding becomes available.

10.Finance matters; a) Bi monthly report. The report was discussed and approved as attached to these minutes.

b) Approve External Audit report. The clerk had chased Wales Audit Office to complete the external audit. This had been concluded satisfactorily with an unqualified report from them. The conclusion of audit report had been circulated to members and was unanimously approved.

c) Consider 2022-23 Budget and set the Precept. The budget had been drafted and circulated. This was discussed at some length. In consideration of the Queens Platinum Jubilee in 2022 it appeared that there were some early stage plans for events in different areas of the community and therefore it was agreed that the CC would not need to organise anything in this regard so the matter was not included in the budget. Purchase and upgrading of equipment to enable hybrid meetings was discussed and training costs included in anticipation of meeting new legislation requirements. The forthcoming elections were discussed, with PCC having advised the CC that they anticipate contested election charges to the CC could be circa £2500 in each ward. Uncontested election costs could be circa £1000. Due to rising household costs members were strongly against increasing the precept, although the estimated expenditure was slightly higher than the current precept value. Voting concluded unanimously that the draft budget be agreed and that the precept remains at £20,000. Clerk to request Precept from PCC.

The three-year plan was discussed in line with financial regulations. It was agreed to slowly build the reserves of the CC to at least cover commitments to financial contracts. To explore grant funding for any projects and encourage community fund raising/ownership of projects to avoid increasing the precept. The impact and long-term effects of the ongoing Covid -19 pandemic were unknown.

11.Update on outstanding highway matters

Llanfihangel Talyllyn parking review. Following the meeting the plan for public consultation from PCC had still not been received. Clerk to follow up.

Double yellow line extension in Llangors as discussed at the last meeting was to be followed up by the Clerk.

Llanfihangel Talyllyn streetlight works were still incomplete. PCC officer visited the village recently and the works are expected to be completed soon.

Road closure notices – there are an increasing number of road closures taking place. Some are for far longer periods of time than need to be, resulting in unnecessary inconvenience to residents. It was agreed to write to PCC streetworks and enquire whether PCC challenge statutory undertakers about the process and in particular if the length of time they apply for closure is absolutely necessary.

The ongoing outstanding highway matters were noted. The water leak on Gilfach road was being resolved. The poor condition of the road from Llanywern to Felinfach to be reported to PCC.
