# Approved Minutes of Llangors Community Council Monthly Meeting Held on Tuesday 14 November 2023 at 7.00pm in the Llangasty Village Hall.

#### 1. Welcome and participation rules for the meeting

Those attending were welcomed and reminded that normal rules for the use of mobile devices applied. There had been no requests to attend the meeting by remote link.

- 3. Declarations of Interest for agenda items as per Members' Code of Conduct. None

## 4. Update on policing in the community

PCSO Lee Garrett reviewed the recent policing matters in the immediate area and he handed out a leaflet on Livestock Worrying By Dogs. Cllrs offered to place copies on appropriate notice boards throughout the community and the Council's website. He further explained that Powys Police were collecting Christmas gift donations of behalf of the charity Calan DVS which is supported by the Mayor of Brecon. These donations of toiletries and similar domestic essentials will be distributed by the charity to Local Women's Refuges and the Montgomery Family Crisis Centre. He would send details to the Clerk which could then also be placed on local notice boards and the website. Cllr Bailey thanked PCSO Garrett for attending the meeting.

#### 5. Appointment of a new Chair

Cllr Bailey confirmed that he had offered to become the chair for a limited period after Cllr Scully stood down although he would not be available for the January and February meetings. There being no other nominations Cllr Jevons proposed Cllr Bailey as Chairperson, seconded by Cllr Beaven. Cllr Bailey was unanimously elected and a declaration of acceptance of office was completed.

#### 10 Council Decisions and Minutes – Proposals for Change

Consideration of this agenda item was brought forward.

Cllr Beaven summarised the document that was distributed prior to the meeting. He explained that he had concluded that improvements could be made to the way that actions were recorded in the minutes to help Cllrs to follow through matters agreed at Council meetings. Such improvement would allow the issue of a dedicated action list document in addition to the draft minutes. He also proposed that the motions that had been considered and decisions reached at Council meetings could be recorded in a fuller format. The proposals were accepted and are reflected in these minutes.

# 6. Consider & approve the minutes of the Monthly Meeting on 8/8/2023 and 10/10/23, and the Planning meetings on 4/9/23 and 13/9/23.

The draft documents had been circulated in advance of the meeting. It was not appropriate for the Council to approve the notes from the informal meeting on the 10/10/23 that were distributed for information only.

# 9. Vacancy for the role of Clerk and Responsible Financial Officer

Cllr Owen reported that the revised job description had been displayed on the Llangors shop's noticeboard and social media but there had been no expressions of interest. An advertisement in the B&R would cost £299 +VAT for 28 days and include online access whereas for paper copy only it would cost £303 + VAT. During discussion other places to display the advert were identified that included OVW, PAVO and local Facebook pages. It was agreed that all option would be pursued in parallel.

It was resolved that the job advertisement be placed in the B&R newspaper at a cost of £299+VAT (Cllr Beaven proposed, Cllr Bailey seconded and all were in favour.) The following actions were agreed.

#### 12. Finance matters: Monthly finance report

Cllr Preece introduced the finance report, circulated prior to the meeting and reproduced at the end of these minutes.

It was resolved that the November Finance Report be accepted as a true and correct record of the Council's finances and the payments made listed therein be confirmed. (Cllr Owen proposed, Cllr Jones seconded and all were in favour)

It was resolved to authorise the following payments due in November: £771.12+VAT to OTM for grass cutting in Llangors, £567.00+VAT to OTM for grass cutting in Llanfihangel Talyllyn, £480.00+VAT to OTM for additional boundary work beyond scope of the grass cutting contract, £299.00+VAT to the B&R for advertising the Clerk vacancy (Cllr Owen proposed, Cllr Jones seconded and all were in favour)

All Cllrs were aware of increasing problems with potholes in local roads. The table of outstanding highway matters had not been updated recently and Cllr Bailey offered to do this on a temporary basis pending the appointment of a new clerk.

She had also washed the Llangors sign as you enter the village from Brecon direction as it was very dirty. Cllr Bailey suggested that cleaning other roads signs should be considered prior to the start of the next holiday season.

Cllr Beaven reported that hedge cutting had also shattered a drain cover in a Llangors footpath. He had reported the hazard to Powys Highways and a replacement had been installed.

Cllr Beaven reported that there had been one recent burial in an existing grave. He had also become aware that the Council's responsibility for the burial ground is not mentioned on the Council's website and he would be drawing up proposals to address this shortcoming.
