Changes to Household Recycling Centres April 2025

Further to the notification in a previous report about the changes to the operation of the Household Recycling Centres to commence in April 2025, I prepared a short briefing containing the questions residents have asked me about the booking system for visits to the centres and the new charges for Do-It-Yourself waste, and the information provided in response by recycling team officers.

The briefing is attached. I will update the briefing with new questions and answers not already included as they arise going forward.

Review of 20 MPH default speed limit on Powys roads - update

As noted in previous reports, Welsh Government began a review of the 20 MPH default limit in September 2024, and has been working with the 22 Welsh local authorities since that date to finalise the roads which will remain subject to the default. As part of the review, Local authorities consulted their populations and reviewed all roads/sections of roads where requests for reviews of the default were received.

The Powys Highways Service reviewed forty roads and has prepared a report for county, town and community councillors setting out its findings and recommendations. The report has been sent to councils directly and I've also attached it here. Councillors (county, town and community) are now asked to feed back their views as to whether all concerns relating to roads in their areas have been captured and addressed by the findings and recommendations.

You will note that none of the county roads within this community council's area was reviewed, but that some roads in neighbouring areas were.

The Strategic Road Network Team at Welsh Government is responsible for the review of 20MPH and 30MPH limits on trunk roads, and expects to complete its report and recommendations (roads where the default limit of 20MPH will change) this Summer. The report and list of roads will be shared with local authorities and with the public, and I'll update the community council and share the report at that time.

Volunteers for School Admissions Appeals Panel

Volunteers from a diverse range of backgrounds and experience are being sought to participate in deciding appeals by parents and carers against decisions about school admissions applications.

Any child refused a place at a school of their choice is entitled to appeal the decision. Appeal Panel members consider the reasons for the choice of school and the reasons for the admission decision and decide whether to uphold or reject the appeal. Training is provided to panel members and a trained clerk advises the panel on legal and administrative issues.

Each panel consists of a minimum of three people and includes both a person with some experience of education, such as a teacher or school governor, and a person without any such experience (a lay member). Apart from the one person with educational experience, panel members are not required to have educational expertise or specialist knowledge. The council seeks to appoint people with a range of different skills and backgrounds, able to bring different viewpoints, experience and fresh ideas to the process. All panel members must be independent of the local authority, the school and the families involved.

Appeals take place throughout the year, but the majority are held between April and June.

Between them, the members of a panel would be able to demonstrate:

-Excellent listening skills and the ability to listen impartially

-The ability to put people at ease

-The ability to assess evidence and evaluate the arguments and evidence presented by both sides

-Decisiveness – appeal decisions are made soon after hearing the appeal

School Admission appeals are generally heard during working hours. Members' availability will always be sought prior to the date of an appeal hearing being set, but applicants should be able to accommodate appeals during the weekday.

Applications should be submitted by 21st March 2025. Applicants will be advised in writing of the outcome of their applications by the end of March and those accepted will be invited for training.

Support with paying rent

Powys residents who receive Housing Benefit or the housing element of Universal Credit may be eligible for support to pay their rent via a Discretionary Housing Payment from the county council.

Discretionary Housing Payments can be used to cover:

-Rent shortfalls, when Housing Benefit or Universal Credit doesn't cover the full rent.

-Rent deposits, when a house move is necessary but a resident is unable to afford to pay the deposit

-Rent in advance, when rent is required in advance for a move to a new home

Prostate testing and advice event

Third sector organisation Prostate Cymru is hosting a public event in Brecon in April providing tests for prostate-specific antigen (PSA), which when present in high levels in the blood might indicate prostate cancer. Testing may be recommended for people who have symptoms that could indicate prostate cancer, and advice and information will be provided at the event.

The event is on Sunday 6th April at Brecon Rugby Club. No times have been provided. People are invited to register an expression of interest using the QR code on the attached flyer, or contact Prostate Cymru using the contact details also on the flyer.

Avian influenza disease control zone extended into Powys

Disease control zones declared after a case of Highly Pathogenic Avian influenza H5N1 was confirmed at a premises near Kington, Herefordshire have now been extended into Powys. A 3km protection zone and a 10km surveillance zone have been imposed by Declaratory Order around the Kington premises to limit the risk of disease spread. A part of the 3km protection zone and 10km surveillance zone, declared by Defra and by Welsh Government, extends into Powys.

Within this zone, bird movements and gatherings are restricted and all holdings where birds are kept must be declared.

Powys County Council's Animal Health Team are notifying Powys bird owners within the 3km protection zone and the wider 10km surveillance zone of their obligation to comply with the measures set out in the Declaratory Order.

Bird owners outside the protection zone and surveillance zone are reminded that the Avian Influenza Prevention Zone (AIPZ) will remain in force across Wales until further notice.

This means all bird keepers in Wales (whether they have pet birds, or a commercial or a backyard flock) must until further notice continue to abide by the mandatory biosecurity

measures, and complete the mandatory biosecurity self-assessment checklist. This includes refraining from touching or picking up any sick or dead birds.

Responsibilities of people who keep birds:

All keepers of birds are asked to:

- be vigilant for signs of the disease, such as increased mortality, respiratory distress and drops in food or water intake, or egg production.

- consult their veterinary surgeon in the first instance if birds are unwell.

If a keeper or their vet suspect that avian influenza could be causing illness in their birds, the keeper must, by law, report this to the Animal and Plant Health Agency.

Keepers must apply strict biosecurity measures to prevent any materials, equipment, vehicles, clothing, feed or bedding that could have been contaminated from wild birds coming onto their premises.

Anyone who finds dead wild birds of any species should report them to the Defra helpline on 03459 33 55 77.

Public health advice remains that the risk to human health from the virus is very low and food standards bodies advise that avian influenzas pose a very low food safety risk for UK consumers.

Scroll down to the grid of options at the base of the page. The complaints and comments function is the first option in the second row in the grid. There is a separate function (second grid on the second row) specifically for complaints and comments about Social Services.

Complaining formally in this way ensures that the complaint is logged and can be tracked by the resident making the complaint.

All of the functions outlined above can be performed via a resident's My Powys account, and 'as a guest' for anyone without an account.

1. Council Information

Powys County Council Budget 2025/26

Further to the briefing for residents on the draft budget shared with the community council in January (attached for reference), the county council discussed and approved the draft budget for 2025/26 at a meeting of Full Council on 20th February.

The draft budget included a proposed Council Tax increase of 8.9% to close the budget gap remaining after the Welsh Government Settlement, income from grants, fees and charges, and proposed savings and cost avoidance totalling £12.2 million had been factored in.

The briefing noted that local authority leaders across Wales were lobbying Welsh Government to implement a funding floor for local authority Settlements. In recognition of the key importance to residents of timely and adequate maintenance and repairs of county roads, the Cabinet proposed, as an additional recommendation in its draft budget on 20th February, to transfer all additional monies received as a result of the implementation of a funding floor to the Highways Service.

The funding floor was confirmed by Welsh Government on 20th February, published with its Final Budget while the Powys Full Council meeting was underway and confirmed at a percentage increase figure of 3.8%. Powys County Council received additional monies equivalent to the difference between its Settlement percentage increase figure of 3.3% and the floor figure of 3.8%. This amounted to £1.226 million.

Full Council voted to approve the recommendation to transfer the funding to the Highways Service.

Full Council met on 20th February and 6th March

The focus of the meeting on <u>20th February</u> was the proposed budget for 2025/26, as published on 14th January, amended to reflect recommendations made by scrutiny committees and the Finance Panel accepted by the Cabinet. As noted above, the budget was approved.

Also discussed and approved was the Corporate Strategic and Equality Plan agreed by Cabinet on 10th February.

Items discussed by Full Council on 6th March included:

- The proposed Council Tax Resolution and Council Tax charges for 2025/26
- A proposed virement amendment to the budget for 2024/25 to remove a request for use of the Housing Revenue Account reserve which is no longer required
- The proposed Pay Policy Statement for 2025/26 setting out the methods by which employee salaries are determined, as required by the Localism Act 2011.

Motions discussed at the meeting comprised:

- A motion that Full Council endorses the report titled The Road Safety Crisis in Powys authored in 2024 by ClIrs Charlton and Church and submitted to Welsh Government; endorses an approach to work with motorcyclists to improve their safety and with partner agencies to improve road safety for all users; and calls on Welsh Government to fund a trial of the Perceptual Rider Information for Maximising Expertise and Enjoyment (PRIMES) motorcycle safety scheme in Powys.
- A motion that Full Council supports the work of a campaign group, Protect Bronglais Services, to prevent reduction of services at Bronglais Hospital in Aberystwyth

Members of the public are invited to submit questions to Full Council. Questions are submitted and responded to in writing in advance of the meeting. Questioners are able to submit one supplementary question each and also to attend Full Council to ask their supplementary questions. They are not required to give advance notice either of their intention to ask a supplementary question or of the question itself. Questions from members of the public on 6th March comprised:

- A request that the county council ensures that none of its pension fund investments are at risk of benefiting companies that may be linked to potential war crimes
- A question challenging the compliance of the council's Home to School Transport Policy with the Learner Travel (Wales) Measure
- A question challenging the lack of 3G football pitch provision in Powys
- A question challenging road surface maintenance of a specific Powys unclassified road.
